Every driver insured by this policy must own another vehicle that he/she uses as his/her principal means of transportation. In no event will any vehicle specifically insured by this policy be used as a principal means of										
transportation by anyone. We require that every vehicle we insure under the Elite Auto Policy be used for occasional pleasure use only. This means, in part, that any auto insured under this policy is to be used only in activities related to participation in auto exhibitions, auto club activities, and leisure/pleasure drives. The vehicle must not be driven at a facility designed for racing, when practicing or testing for pre-arranged races, speed contests, time trials, driver's education, or on-track events.										
However, we have made an exception for participation in auto shows held at such a facility only if the show involves no driving of your vehicle and no other vehicles are driving in the facility during the show. Every auto insured must be driven no more than the annual mileage option selected, unless a Trip Extension Endorsement is purchased prior to additional use. Every auto must also be kept in a locked garage when not in use. This is intended only as a general overview
